2022/062 (TC)	<p><b><u>ADJOURNMENT FOR PUBLIC PARTICIPATION</u></b> To adjourn the meeting for 15 minutes to allow members of the public to make representation on the business of the agenda for the meeting. No resolutions can be under public participation.</p> <p>Four members of the public were present at the meeting and raised a number of issues they wished to discuss with Councillors.</p> <p><b><u>Back Street Projects</u></b></p> <p>Residents from Carr Road were in attendance at the meeting to discuss the possibility of having the back street there resurfaced. The Council had recently decided to delay the resurfacing of Carr Road to concentrate on other areas which had been identified as priority areas.</p> <p>Councillors discussed this with those present and explained that the responsibility of the roads actually lies with Lancashire County Council. The Town Council are putting some funding towards back streets within the town, but only have a limited amount of money available for works and there are many back streets in the town which are in need of resurfacing.</p> <p>Members pointed out that although the works at Carr Road were not authorised at the July meeting, they were not blocked altogether and it was resolved that the street would come back to a future meeting for consideration.</p> <p>The Finance and General Purposes committee meet each month to discuss which streets are to be considered and request that Pendle Borough Council put those chosen out to tender. Members agreed that Carr Road would again be considered at a future meeting of the Finance and General Purposes committee.</p> <p>In the meantime, the residents were encouraged to contact Lancashire County Council to request that they also consider funding the resurfacing of the back street at Carr Road.</p> <p>The update was noted.</p>

<p>2022/068 (TC)</p>	<p><b><u>NELSON TOWN DEAL</u></b></p> <p>To discuss the Nelson Town Deal and prepare for ways to which Nelson Town Council can assist with the process.</p> <p>Councillor Ali began the item with a detailed update for the members of the public present on how the Town Deal was obtained, how much was received and how the money will be allocated to various different projects across the town centre.</p> <p>The key updates from the latest town deal meeting were as follows:</p> <ul style="list-style-type: none"> <li>• Pendle Borough Council have now allocated funds for the CPO process at the Pendle Rise Shopping Centre. This is encouraging news and he will provide further updates at future meetings on how things are developing.</li> <li>• Many different projects for the funding have been identified by specialist consultants who deal with town centre planning</li> <li>• A consultation on the parks project is taking place in November at various locations across the town which residents are invited to put forward their suggestions. One of which will take place at the Unity Well Being Centre on Thursday 10<sup>th</sup> November from 10:00am to 13:00pm.</li> <li>• A similar consultation will also take place around ideas for the Trafalgar House building on Market Street. No dates have been announced for this as yet but they will be made available on the Pendle Borough Council website soon.</li> </ul> <p>He also reminded Councillor present and the public in attendance that the Town Deal</p>

2022/069 (TC)	<p><b><u>ALLOTMENTS</u></b> To discuss a number of items in relation to the allotments in Nelson.</p> <p>The Assistant Town Clerk briefly updated Members around the allotments query raised at the last meeting. The Allotments Society had previously asked that monies paid by their Members to this Council be re-allocated to them and that future rents are paid directly to the society rather than to the Council to save time waiting for approval at either Full Council or Finance and General Purposes committee meetings.</p> <p>This is currently with the legal department at Pendle Borough Council who are looking to see where ownership of the sites is and what was agreed in the initial transfer of services to the Town Council.</p> <p>Members noted the update.</p>

	<p>Given the struggles that many residents are likely to face following on from the cost of living and inflation crisis, Members discussed the possibility of using the Revive Café in the Unity Well Being Centre as a Warm Hub over the winter where residents could meet for a cup of coffee and something to eat and to keep warm.</p> <p>Proposed by Councillor Ali and Seconded by Councillor Sarwar, and  <b>RESOLVED:</b> That the Revive Café is allocated as a Warm Hub over the winter months and that costings are identified and brought to a future Finance and General Purposes committee meeting for review.</p>
2022/073 (TC)	<p><b><u>WEBSITE AND TOTEM</u></b>  To note the takeover of the town centre website and town centre totem from Pendle Borough Council as approved at the recent Events, Promotional and Marketing Committee meeting.</p> <p>Following the approval of the Council taking over the town centre website and totem, a report had been provided by Mike Williams of Pendle Borough Council asking the level of support the Council would require in terms of running both features.</p> <p>Proposed by Councillor Hannah-Wood and Seconded by Councillor N Pearson-Asher, and  <b>RESOLVED:</b> That Option 1 from the report (Hosting and Technical Support - £1,500) is selected and reviewed on an annual basis.</p>
2022/076 (TC)	<p><b><u>CAR PARKING AT THE STEVEN BURKE SPORTS HUB AND CRAVENDALE AVENUE</u></b>  To consider a funding request for car parking at the Steven Burke Sports Hub and at Cravendale Avenue.</p> <p>Barrowford and Western Parishes Committee from Pendle Borough Council had requested funding support to go towards car parking and signage at various different locations leading to the Sports Hub and access from Cravendale Avenue. The total request was for £3,000.</p> <p>Members reviewed the documentation submitted and agreed that partial funding would be appropriate given that the majority of works were to fall within the Barrowford boundary line. Councillors agreed to only fund the works which fell within the Nelson Town Council boundary line – ie on Cravendale Avenue.</p> <p>Proposed by Councillor Ul-Haq and Seconded by Councillor Ali, and  <b>RESOLVED:</b> That £500 is given to the project for the bay markings and £150 for the signage at the Cravendale Avenue section of the works.</p>
2022/077 (TC)	<p><b><u>TRANSFERRED SERVICES</u></b>  To receive reports and consider any actions required in relation to transferred services.</p> <p><u>CCTV monitoring</u></p> <p>The Assistant Town Clerk reported that CCTV monitoring report for August had now been received. No major issues were identified. No report for September has arrived for circulation yet.</p> <p>The update was noted.</p> <p><u>MUGAS and Play Areas</u></p> <p>The Assistant Town Clerk updated Members by informing them that quotes had now been received for works at Bradshaw Street following resident complaints of footballs going over the existing fencing and into neighbouring properties. This will be presented to the Finance and General Purposes committee for discussion.</p>

	<p>Quotes are also being obtained for repair works to the swing safety surfacing at Lomeshaye Park following the recent review of MUGA's and Play Areas.</p> <p>Councillors also noted that a bin has been damaged at Marsden Park Play Area. This is to be reported to Keith Higson and the team at Pendle Borough Council to get it repaired.</p> <p><b>Action:</b> The Assistant Town Clerk to report the above to Keith Higson.</p> <p>Members noted the update.</p> <p><u>Parks Services</u></p> <p>A public consultation is due to be scheduled in the next few weeks for the Town Deal works due to be carried out at Walverden Park.
