## **NELSON TOWN DEAL**

To discuss the Nelson Town Deal and prepare for ways to which Nelson Town Council can assist with the process.

Councillor Ahmad had recently attended a Town Deal meeting and an Accessible Nelson meeting where the main topic of discussion was again the Sagar Street area works as well as other highway works in and around the town centre. These are currently ongoing and all access works in the town won't be completed until late 2026. Pendle Rise should be under full ownership of the Council by November 2025 and it should be demolished by March 2026.

The Pendle in Place group also discussed how the allocations should be made in terms of the £20,000,000 funding which was granted. Ideas around community cohesion amongst other things. The next meeting will take place on Friday 19<sup>th</sup> December 2025 to discuss this further.

#### **GIB HILL PROJECT - UPDATE**

To receive an update around the project at Gib Hill and to appoint two delegates to the Gib Hill Guardians project as representatives of this Council

Will Stephenson from the Gib Hill Guardians project was present at the meeting and gave Members a brief update as to what works are ongoing at the site. The main works taking place so far are mowing of the field, improving access routes, installing new footpaths and planting of new trees. So far approximately £11,000 has been spent on the project. The team are also actively seeking funding from other resources and thanked Nelson Town Council for their contribution made last year.

A new website (gibhill.org) has also been created and the Facebook page has over 500 followers.

Members were asked to nominate two Town Council representatives to be appointed to the Gib Hill Guardians team who will then be able to act as delegates between the Council and project management for updates.

Members stressed that before any funding is released, a copy of the organisations constitution must be provided and that the cheque will be paid into the business account.

All grant applications must ensure that all the relevant documentation is provided in support of the application form to ensure that Members have the correct information to consider applications.
