Quotation One: Clean carpets in square meters: 132 @ £1.25 per sq meter £165 Clean standing chairs: 110 @ £1.50 per chair £165.00 Degreaser and deodoriser: £20.00

Estimate Two: Entrance hallway, two ground floor conference rooms, upstairs landing and conference room £200. Red chairs chargeable at £2.00 per chair

Proposed by Councillor Ali, and Seconded by Cllr Mashuq, and **RESOLVED:** That the committee accepts quotation one. The Clerk is delegated to contact the company and place an order for the deep clean of the chairs at a cost of £1.50 per chair
