2018/005 VOTING RIGHTS FOR NON-COUNCILLORS

(TC)

The Council for clarification purposes is asked to note that in accordance with Standing Orders and LGA 1972, s102, the Council may appoint non-councillors onto committees, sub-committees and advisory committees, with or without voting rights with the exception of the committee which regulates and controls the finances of the Council. Non-councillors will be summoned to attend meetings, receive agendas and background papers to meetings and can speak at a meeting whether or not they can vote. Where a non-councillor has voting rights, they are subject to the Code of Conduct for the Council.

2018/006 **GENERAL POWER OF COMPETANCE**

To consider resolving the use and eligibility of the General Power of Competence Order until the next ordinary elections in May 2019. In accordance with Parish Councils (General Power of Competence) Order 2012, the Council meets the prescribed conditions for eligibility to use the General Power of Competence as set out in the Localism Act Chapter 1, section 1 to 8 (advice sheet attached)

The prescribed conditions for eligibility which the Council must meet are:

- Two thirds of Councillors declared to have been elected at an ordinary election, uncontested at an ordinary election one elected at a by-election. 16 Councillors represent two thirds of Nelson Town Council seats.
- The Council must have a qualified Town Clerk with a minimum CILCA qualification, completed relevant training in the General Power of Competence and must additional pass the General Power of Competence module of CILCA. The Town Clerk is fully qualified and trained in its uses.

The Clerk provided an update to Council on the eligibility and the use of the power. It was explained that the General Power of Competence is the power of 1st resort and it gives the council the power to do anything an individual can do unless there is a statutory prohibition and so long as they don't break the law. The criteria was currently met by the Council who now has in place a qualified Clerk who is trained in the use of the General Power of Competence.

Proposed by Councillor Mashuq Hussain, Seconded by Councillor Kaamran Latif, and **RESOLVED:** That the Council declares the eligibility and use of the General Power of Competence in accordance with the General Power of Competence Order 2012. The council declares that it has had two thirds of Councillors elected in May 2015 and a qualified Town Clerk who has completed the CILCA and the General Power of Competence module.

2018/007 REVIEW OF DELEGATION ARRANGEMENTS TO COMMITTEES, SUB-COMMITTEES AND OFFICERS

committee is tasked to deal with all elements relating to building maintenance and services contracts eg legionella testing, it was felt that any contracts relating to caretaking and cleaning should fall within the remit of the Personnel committee. It was noted that any business relating to Allotments, had now been merged within the remit of the Environmental Improvements committee.

Members raised concerns that due to less than half of the Civic year remaining, a byelection must be avoided to save costs. However given that the member had breached the non attendance legislation, the process must therefore be followed and a casual vacancy be triggered.
