2018/114 REPORTS FROM BOROUGH/COUNTY COUNCILLORS AND INVITED GUESTS (TC) 2018/114.1 - To receive reports from the Borough or County Councillors

County Councillor Azhar Ali reported on the budget process at Lancashire County Council. Since 2010 half a billion cuts had been made to date. This year there were over £77 million cuts of savings made. Some proposals included switching off street lights until 5am, however it was felt that this would have an impact on crime where police numbers were already short. It was reported that there may be a possible closure of the nursery in Wolverden. Other budget cuts would have an impact on Adult Social care and the number of carers and services that help with respite support. A discussion took place surrounding the programme of replacing the orange street lights to LED street lights.

Proposed by Non-Councillor Azhar Ali and Seconded by Councillor Zafar Ali, and **RESOLVED:** That a letter is sent to the Chief Executive cabinet member for Wellbeing and Council leader, expressing the concerns of the possible closure of the nursery in Wolverden. The letter is to include the Town Councils view of other budget service cuts proposed by Lancashire County Council.

Cllr Alan Neal reported that he attended a meeting in London with the National Association of Local Councils (NALC) earlier this week. Comments were made surrounding the positive work of Nelson Town Council following the recent appointment of their new Town Clerk, Safia Kauser. NALC passed on their congratulations to the Council on the Clerks appointment and praised the work of the Town Clerk/RFO who is very highly thought of by NALC.

It was reported that recent LALC meetings have had a very poor turnout and if delegates cannot attend then the Council could send substitute delegates comprising of two to three members. Positive comments were also made in regard to the recent asset transfers and the services NTC had protected by delivering them locally. The Chairman Cllr Zafar Ali thanked Councillors Sajid Ali, Eileen Ansar and Sheila Wicks who had been involved with asset transfers.

2018/117 FORMAL TOWN COUNCIL RESPONSE - ELECTORAL REVIEW OF PENDLE BOROUGH COUNCIL

To consider a formal Town Council response as a result of the electoral review to be undertaken by the Electoral Commission, requested by Pendle Borough Council. Presentation notes from the Boundary Commission provided to parishes at the meeting held on the 22nd November 2018 were circulated at the last full council meeting.

Note: Pendle Council is looking to reduce significantly the number of its councillors. This is done by way of a periodic electoral review carried out by the Local Government Boundary Commission. Following discussions with the Commission the review is likely to start in December/January. The Commission will look at the current Borough wards and is likely to recommend very significant changes to these. This can have implications for parish and town councils which it will need to take into account. If a parish does not have wards then the whole of its area must lie wholly within a single Borough ward. If it does have wards then each ward must lie wholly within a single Borough ward. This may mean changes to existing parish wards and/or the creation of new wards. To be clear though it will not however lead to any changes to the boundaries of a parish.

It was commented that the last boundary review was carried out in 1999. The new parishes were formed including Colne and Nelson in 2009. Pendle Council is suggesting that the total number of borough councillors is reduced from 49 to 39, however these impact on some two and three ward councillors representing the Town Council. It was felt that there should be uniformity in the number of ward members.

Proposed by Non-Councillor Azhar Ali and Seconded by Councillor Zafar Ali, and **RESOLVED:** That a letter is sent to the boundary commission to express the view of Nelson Town Council (5 abstentions)
