2018/172 <u>ELECTORAL REVIEW OF PENDLE BOROUGH COUNCIL</u>

To consider a further response to the boundary commission review. The commission now invites proposals from the council, interested parties and members of the public on a pattern of electoral wards to accommodate those councilors (correspondence previously circulated)

The proposal for the Nelson areas would be broken down as follows:

Ward 8 – Greater Marsden (3 Member Ward)

This ward comprises of polling districts: MA, MB and SB. The electorate would be 5,662 falling within the acceptable range of electors to ensure electoral equality.

Ward 9 - Nelson North (3 Member Ward)

This ward comprises of polling districts: BM, BN, BO, SA, CB and CC. The electorate would be 6,725, falling within the acceptable range of electors to ensure electoral equality.

Ward 10 - Nelson West (3 Member Ward)

This ward comprises of polling districts: BL, WI, WH, BQ and 720 electors from BR. The electorate would be 6,040, falling within the acceptable range of electors to ensure electoral equality.

Ward 11 - Nelson South with Brieffield (3 Member Ward)

This ward comprises of polling districts: WA, CA, RB, BR less 720 electors. The electorate would be 6,553, falling within the acceptable range of electors to ensure electoral equality.

Proposed by Non-Councillor A Ali and Seconded by Councillor Z Ali, and **RESOLVED:** That Nelson Town Council proposes one additional Councillor to the total proposes to increase the number to 34 to take into consideration the rural wards.

A meeting has been set up with Philip Mousdale at Pendle Borough Council on 11th June 2019 to bring together a working group to discuss the next steps forward in relation to parks services in the town.

Councillor Z Ali has recently been involved in meetings with the Friends of Walverden Park group who have informed him that services have lessened in the parks, yet the Town Council contribution of £60,000 has remained the same – this raises the question of where is the money going that is being contributed?

Karen Howarth, a member of Friends of Marsden Park who was in attendance stated that there is also a serious lack of volunteers helping out in the town's parks — something that will need to be addressed as things move forward. There is also an old listed building in Marsden Park that is not being maintained even though Pendle Borough Council have previously stated they would send somebody out to do any necessary repairs.

Proposed by County Councillor A Ali and Seconded by Councillor Z Ali, and **RESOLVED:** That Nelson Town Council write to Dean Langton at Pendle Borough Council to ask the question as to why the building in Marsden Park is not being maintained and to set out what the working group that is about to be formed can assist with.
