2018/019 COMMUNITIES CLEAN-UPS/ LITTER PICK UP DATES

(EI) 2018/019.1 - To receive an update from a representative from 'Pick up For Pendle' voluntary group on the recent pick-ups in the Nelson Town Council area and upcoming future dates

Peter from Pick-up from Pendle was present at the meeting and addressed the committee. It was confirmed, in his opinion that Nelson remained the worst town for litter. A recent pick-up had taken place for Southfield and Whitefield Ward and the bottom of Scotland Road. A pick-up was scheduled tomorrow for the Walverdon ward. Peter confirmed that the long-term strategy for his group was to create awareness. Nelson was a prosperous and vibrant town however it was lost due to it's industry. PU4P were recently contacted from a Whitefield group who combined forces and assisted them with a pick up. Ideas were shared on how Councillors could get involved with the group. Peter suggested that at least one Councillor from each of the six wards could initiate a pick up for their area. Most of the nasty/grotty areas had been spot cleaned however the problem now is with reoccurring litter.

A mosque group had been set-up for litter picking and met from 2-4pm. They had been inspired by Peter and PU4P. Peters group has had a good impact and positive comments have been received.

The Mardsen ward councillors had identified issues in their own areas and are working closely with the friends of Marsden park.

Action: Clerk to contact ward councillors to agree a date for a pick-up in their area. Clerk to inform Peter from PU4P of the dates for each ward. Lead Councillor from each ward to work with PU4P to undertake the pick up and create awareness

2018/019.2 - To consider marketing the dates for the 'Pick up for Pendle' voluntary groups for inclusion on the Town Council website and social media sites
Peter confirmed that a facebook page was set-up and an email is circulated to a number of parties including councillors to inform them about the pickup. The Clerk suggested that the Town Council could set-up a page on their new website informing residents about PU4P. Peter confirmed that a similar page is set-up on the Borough Council website with all pick up details.
