FOOD FESTIVAL 2021

To consider a request for £5,000 Scott Dawson's to support the planned Food Festival in Nelson Town Centre due to take place in September 2021.

Scott Dawson's had been in touch with the Council requesting a £5,000 contribution to go towards the annual Nelson Town Centre Food Festival. This money has been provided for the last two festivals in what is usually a very busy town centre event.

Whilst in principle Members were not against the request, they felt that for such a contribution in a limited 2021/22 events budget, they would like to see further details from Scott Dawson's in relation to how local businesses would be promoted, and that stalls would be provided free of charge for any Nelson businesses wishing to participate.

Proposed by Councillor Bashir and Seconded by Councillor Tennant, and

RESOLVED: That the item is deferred to the July Full Council meeting for a decision to be made, and that the extra detail around promoting Nelson businesses and inclusion of stalls for Nelson businesses is confirmed by Scott Dawson's.

Action: The Assistant Town Clerk to write to Scott Dawson's requesting the above information is provided before July's Full Council meeting to enable Councillors to make a decision.

If you can provide this for us within the next couple of weeks we can look at getting a decision made for you at the next Full Council meeting on 07th July.

I understand that my colleague Jen Rawsthorne from Liberata Property Services has contacted you previously and that Nelson Town Council have agreed to join in a Section 104 Agreement and associated easements with the Borough Council of Pendle and United Utilities which will provide a foul water connection to the Borough Council's land, on which five dwellinghouses are to be erected. For easy reference plan number NE/BAM/NTC/2 (first attachment) shows Nelson Town Council's land edged green, the short length of new foul sewer to be laid in the Town Council's land is shown by a solid thick black line and the point of connection is shown by a circle coloured black, the area coloured yellow on the plan indicates the easement strip and protected working width. The Borough Council's land, in which the new foul sewer is to be laid is edged red on the plan. Following completion of the documentation the new foul sewer will, in due course, be adopted by United Utilities and will be maintained by United Utilities pursuant to the Section 104 Agreement.

Accordingly I attach:-

Dear Councillor Zafar Ali,

I hope you and the Nelson Council community are keeping well during this time.

I am emailing from Remembering Srebrenica, a charitable organisation funded by the Ministry of Housing, Communities and Local Government and supported by the Foreign, Commonwealth & Development Office. Our aim is to raise awareness of the genocide in Bosnia and bring people together to tackle hatred and help build safer, stronger

communities here in the UK. Since its creation in 2013, Remembering Srebrenica has educated 130,000 young people on the lessons from Srebrenica, organised over 8,500 community actions right across the country and created 1,450 Community Champions who pledge to stand up to hatred and intolerance in their communities.

Each year, we raise awareness during Srebrenica Memorial Week by collaborating with councils, schools, faith groups and other organisations with over 1,700 acts of commemoration taking place in 2020. This year's Srebrenica Memorial Week will be taking place from 4th July to 11th July where communities across the UK will commemorate the 26th anniversary of the genocide, where over 8,000 Bosnian Muslim Men and Boys were murdered, simply because of their faith.

The theme for 2021 is 'Rebuilding Lives'. In albeit very different ways the COVID-19 pandemic has brought loss and difficulties to millions, shattering individuals and communities, who are now looking to rebuild their lives. As we move forwards to rebuilding our communities in the wake of the many health and economic challenges which people with divisive agendas are all too keen to exploit, we will remember the spirit of survivors who, despite the horrendous hatred and destruction they were subjugated to themselves, have been rebuilding their lives with dignity, humanity and without calling for retribution or promoting division or hatred.

We kindly invite Nelson Council to commemorate Srebrenica and take a stand against hatred and intolerance this Memorial Week by holding an act of commemoration between the 4th and 11th July.

Commemorations can vary and are very simple to organise. There is no singular way to commemorate, and our team is on hand to provide you with as much support and guidance as possible. Some suggestions as to what you can do are:

- 1. Hold a Coffee Morning to bring people together to remember the Bosnian genocide and discuss the importance of strong communities;
- 2. Hold a minute's silence in your organisation;
- 3. Post our 2021 statement of commemoration on your website or social media;
- 4. Light a candle to mark Srebrenica Memorial Day and post a picture on social media;

We have a range of resources available to support your act of commemoration, including a statement to mark the anniversary, speeches, interfaith prayers, and a guide to holding a commemoration coffee morning, which can be found here.
